What is this product?

Type: Flexible, income accumulation

Objectives: The Fund is actively managed and aims to achieve capital growth and generate income. The Fund does not refer to a Benchmark.

Investment Policy:To achieve these objectives, the Fund invests primarily in a diversified portfolio of international bonds and equities and money market instruments including through Undertakings for Collective Investment in Transferable Securities (UCITS) and/or other Undertakings for Collective Investment (UCIs). The Fund may invest up to 30% of its net assets in equities and other similar financial instruments and may use derivatives for hedging purposes. The Fund's investment decisions are made on a discretionary basis. The value of the Fund is calculated and expressed in Euros

Redemption: The frequency of partial or total Redemption held by unitholders is aligned with the frequency of calculation of the unit value of the unit, which is determined on a daily basis, except on days when national stock exchanges are closed and on public holidays, when national stock exchanges are also open.

Maturity: The Fund is established without limits of duration

Intended retail investor: The Fund is intended for a Retail Client with a minimum level of theoretical knowledge and financial experience, with a moderate ability to bear financial losses, and who aims to achieve growth in invested capital, over a recommended time horizon of at least 5 years, consistent with the level of risk assumed. In accordance with the Regulations, the Fund may be subscribed for an amount, net of subscription fees and expenses, of not less than 2.500 euros.



What are the risks and what could I get in return?
