Objectives and investment policy

This Fund is actively managed and seeks to maximise capital growth. The Fund does not aim to replicate the composition of the Benchmark: 5% Merrill Lynch Euro Government Bill Index and 95% MSCI World Index converted in EUR. The Fund also invests in securities which are not included in the indices or present in different proportions.

Degree of discretion with respect to the Benchmark: limited.

In order to achieve the above said aims, the Fund invests mainly in shares and similar securities and also in convertible bonds or other types of bonds.

The Fund may invest, on a residual basis, in money market instruments with duration of less than 12 months and hold liquid assets, including bank deposits.

The Fund may invest up to 10% in Undertakings for Collective Investments in Transferable Securities (UCITS) or Undertakings for Collective Investments (UCI).

The Fund's investment decisions are made on a discretionary basis.

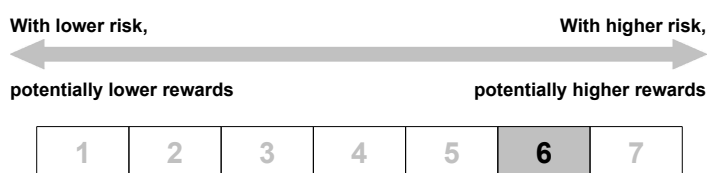
In order to achieve the above aims, the Fund can use derivatives not only for hedging purposes.

Any income received by the Fund is reinvested.

The Fund's value is calculated and expressed in Euros with the foreign exchange risks left unhedged.

Investors can buy or sell shares of the Fund on a daily basis (full bank business day).

Risk and reward profile



Significant risk(s) for the Fund not taken into account in this indicator include the following:

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

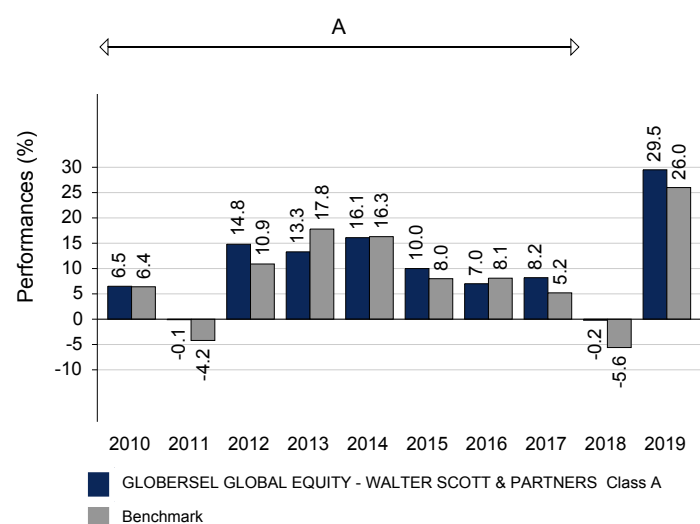
