What is this product?

Type : Flexible fund, Income Accumulation

Objectives : The Fund is actively managed and aims to make capital gains. The Fund has no reference Benchmark.

Investment Policy: The Fund mainly invest in different classes of international transferable securities, including but not limited to equities and bonds, and in money market instruments with duration of less than twelve months, mainly through Undertakings for Collective Investments in Transferable Securities (UCITS) and/or other Alternative Investment Funds (AIFs). It is expected that the Fund will have a relevant exposure to equities, and that in normal market conditions more than 20% of the net assets of the Company will be exposed to equities. The Company may make all of its equity or its bonds investments via UCITS and/or AIFs. The Fund may also invest in AIFs and, generally speaking, in assets with valuation timing longer than weekly, up to 30% of its Net Asset Value in order to capture any potential market opportunity that will arise. However, the Fund may invest directly in funds, shares, bonds, money market instruments and derivatives of any kind and nature to complete its portfolio by adapting to the situations on the market. The Fund may also use a leverage effect: the maximum expected level of leverage is 200% of the net assets according to the commitment methodology. The Fund's value is calculated and expressed in Euro.

Redemption: Unit holders may request redemption of the units seven calendar days prior to the Valuation Day (every friday of the week), by sending an irrevocable redemption instruction to the Depositary Bank, to the Management Company, to the other banks or other institutions authorised for this purpose by the Management Company accompanied by subscription confirmations or certificates representative of units, as the case may be.

Maturity : The Fund is established without limits of duration

Intended retail investor : This Sub-Fund is addressed to institutional investors. The investor is warned that all investments involve a percentage of risk and that it cannot be guaranteed that investment policy objectives will be achieved. The minimum amount of the first subscription is 125,000 euro. The minimum amount of subsequent subscriptions is 10,000.00 euro.

What happens if Ersel Gestion Internationale S.A. is unable to pay out?
